

# Childcare Service Plans for 2024-2025

St. John's Parish Day School Childcare Services includes multiple options for families of both Early Childhood and Lower School students. Hours of operation during the regular school day begin at 7:00AM until the beginning of the school day for Before Care and from the end of the school day until 6:00 PM for After Care. These programs are operated through the SJPDS Auxiliary Programs and are licensed through the State of Maryland's Office of Childcare.

# **Plan Options**

### Plan 1-"Full Time"

Access to Before and After Care programs Monday through Friday. This includes all of the school's noon dismissal days (approx. 5-7 days).

#### Plan 2- "Before Care"

Access to the Before Care program Monday through Friday.

## Plan 3- "After Care"

Access to the After Care program Monday through Friday.

## Plan 4- "Drop-In"

\*With advance notice of intent to attend and a completed registration, access to Before and/or After Care programs Monday through Friday.

# Noon-Day Dismissal- "À la carte"

With the exception of "Full Time" plans (Plan 1) where care for noon dismissals is included, families will have the opportunity/be required to register for care for noon dismissals. Registration is required for these plans and will remain open until a week before the scheduled date. Registration is not limited to families who have previously registered for other Child Care Service Plans.

# Late Pick-Up Fees
