



Childcare Service Plans for 2025-2026

St. John's Parish Day School Childcare Services includes multiple options for families of both Early Childhood and Lower School students. Hours of operation during the regular school day begin at 7:00AM until the beginning of the school day for Before Care and from the end of the school day until 6:00 PM for After Care. These programs are operated through the SJPDS Auxiliary Programs and are licensed through the State of Maryland's Office of Childcare.

Plan Options

Plan 1- "Full Time"

Access to Before and After Care programs Monday through Friday. This includes all of the school's noon dismissal days (approx. 5-7 days).

Plan 2- "Before Care"

Access to the Before Care program Monday through Friday.

Plan 3- "After Care"

Access to the After Care program Monday through Friday.

Plan 4- "Drop-In"

*With advance notice of intent to attend through a digital form available on the Childcare Services website and completed registration, access to Before and/or After Care programs Monday through Friday.

Early Dismissal Care

With the exception of "Full Time" plans (Plan 1) where care for noon dismissals is included, all families will have the opportunity/be required to register for early dismissal care. Registration is required for these plans and will remain open until a week before the scheduled date.

Late Pick-Up Fees

While we understand that things happen that prevent timely pick up during an emergency. Please be respectful of our staff on a daily basis and arrive by 5:59 PM. Late Pick-Up Fees will be automatically assessed for pick-up beginning at 6:00 PM. \$30 for first 10 (6:00-6:09 PM) minutes and one dollar per minute starting at 6:10 PM. Chronic issues of lateness may result in dismissal of this program.

We do not offer Childcare Services on days when the school is closed and/or on select days as noted on the school's calendar (the last day before the Christmas Holiday and the last day of the School's academic year).
